Dear Course Coordinator,

All the TTIs are requested to follow the Covid 19 Protocol laid down by the Govt. of India, while conducting the theory and practical examinations, August 2021.

You are requested to kindly note the following in respect of:

## a. Eligibility criteria for appearing in Theory / Practical examinations

- 1. Every candidate has to pass internal practical examinations to be eligible for external practical examinations.
- 2. Every candidate has to pass internal theory examinations to be eligible for external theory examinations.
- 3. Hall ticket will be issued only to the students who have passed the internal theory and internal practical examination in the concerned subject.

## b. Procedure for submission of marks

- 1. The last date for internal theory, internal practical & external practical online mark entry is 30<sup>th</sup> July,2021.
- 2. The hall ticket will be made available to the students only on completion of above 3 categories of marks.
- 3. Internal theory, internal practical and external practical examination marks submitted after the last date (30<sup>TH</sup> July 2021) will not be considered.
- 4. After completion of online internal mark entry kindly take a printout and send the scanned copy to NIEPMD-NBER through email ID <a href="mailto:nber.certification@gmail.com">nber.certification@gmail.com</a>, duly signed by the Course coordinator.

- 5. After completion of external practical examination, enter the marks in the online portal and in the prescribed mark entry form.
- 6. The scanned copy of the same should sent to NIEPMD-NBER email ID <a href="mailto:nber.certification@gmail.com">nber.certification@gmail.com</a>, duly signed by the examiners.(Internal & External) with the seal and signature of the head of the institution.
- 7. The marks submitted online to NIEPMD-NBER shall be final and **NO CHANGES** in marks shall be entertained.
- 8. Therefore, please check and recheck for any typographical or any other errors before submitting marks ONLINE.
- 9. In case of any discrepancy in the marks submitted online and scanned copy received, the marks obtained as in the SCANNED COPY received shall only be considered.

All the TTIs are requested to send the TA/Honorarium claim form of the Internal/External practical examiner to NIEPMD-NBER on or before the 14<sup>th</sup> August 2021.
