- All study centers are requested to refer **THREE** practical examiners on or before **15th December**, **2022** through NIEPMD-NBER portal with their full Address, Education details, Qualification, Contact Number (WhatsApp) and valid email ID.
- Make sure the fees payment for all candidates before applying (if payment pending, link will be disabled).
- As per RCI's Scheme of Examination 2018, Sl No. C.1.1, 75% of attendance is must for apply the Practical/Theory examination and as per Sl.No C.1.2, 5% relaxation in attendance can be allowed by the head of the Institution for valid reasons.
- Make sure the internal marks for all subjects Theory/Practical are pass before applying the external examination (if internal subject fail/absent, not qualified for external theory/practical examination).
- After completion of examination, you are requested to enter the marks in appropriative subjects.
- As per the no. of papers and students' weightage, practical examination need to be conducted according from 1 to 3 days.
